Hui-Wen Vivian Tang Ming Chuan University, Taiwan

Speech Title: Developing an Organizational Climate Assessment Tool for Junior High School in Taiwan

Abstract: The study aimed to benchmark a school climate assessment tool for junior high school in Taiwan. Derived from an evolving body of research studies on components of school climate and expert panel discussions, an initial framework was extrapolated from prevalent reviews of school climate components into a 22-factor model clustered under five-dimensions. Statistical procedures, including EFA and CFA, were employed to validate the a priori factor structure of the construct. The school climate assessment tool can be used in scenario-based analyses of junior high schools, so as to prioritize climate components of schools in need of change. Armed with such scientific inquiry, school principals, teachers and faculty are in a position to engage in developing systematical strategies for improving school climate. Future studies may expand the present undertaking by incorporating sociological, bio-ecological and psychological perspectives to develop school performance appraisals, targeting at providing incremental and value-added contributions to leverage the competitive advantages of Taiwan's junior high school education.



Prof. Gary E. Swanson Dimage Studios LLC Ellwood City, USA

Gary E. Swanson is an internationally recognized and highly acclaimed educator, photojournalist, documentary and news producer, director, editor, speaker and consultant. He has given numerous keynote speeches, served as organizer and chair at conferences, presented workshops and lectured at embassies, festivals, and universities throughout China, South Africa, India, Sri Lanka, Papua New Guinea, Japan, Korea, The Philippines, Thailand, Cambodia, Malaysia, Vietnam, Laos, Indonesia, Singapore, Greece, Italy, Germany, Jordan, Spain, Portugal, Peru, the United Kingdom, British Columbia, and the United States. Professor Swanson is a three-time Fulbright Scholar to Portugal and the People's Republic of China. From 2007-2015 Swanson was the Mildred S. Hansen Endowed Chair and Distinguished Journalist-in-Residence at the University of Northern Colorado, USA. Previously, Swanson was Professor and Director of Television for nine years at the Medill School of Journalism at Northwestern University. He has also taught at DePauw University in Indiana and at Elon University in North Carolina. In 1992 Swanson covered the Olympics in Barcelona, Spain for NBC News, and in 2008 was commentator for China Central Television International (CCTV-9) and their live coverage of the Beijing Olympic Games. Professor Swanson continued his on-air work with CCTV-4 as distinguished live guest and commentator in London the summer of 2012.

Swanson has earned more than 76 awards for broadcast excellence and photojournalism including three national EMMY's, the duPont Columbia Award, two CINE "Golden Eagles," 16 TELLY's, the Monte Carlo International Award, the Hamburg International Media Festival's Globe Award, the 2011 Communitas Outstanding Professor and Educator award, the 2012 Professor of the Year Award, the 2016 Distinguished Alumni Award in Education from the University of Illinois, and many others. His photography has won numerous awards and his works have been published in magazines, books, and displayed in art galleries worldwide.

Speech Title: Investigative Journalism: Going Undercover to Reveal the Story

Abstract: It is investigative journalism at its most compelling. You suspect that a supermarket chain is selling old meat so you get some ABC network television employees jobs in one of the stores by falsifying identities and place tiny, hidden cameras on them. If you're right and everything goes according to plan, then the evidence will be there on camera, on screen – shots of employees affixing new dates to packages of old meat. The resulting news story provides the public with meaningful evidence that affects them directly. In this case and others journalists used some form of deception to gain access and to get information. And for American news organizations, this is also journalism at its most ethically questionable in which reporters and producers struggle between keeping the principle of honesty and fulfilling their journalistic obligation of truth telling.



Assoc. Prof. Yip Mum Wai Tanku Abdul Rahman University College, Malaysia

Assoc. Prof. Dr. Yip Mum Wai holds a Diploma in Materials Engineering (1997) and MSc in Manufacturing Systems Engineering (1998) from University of Warwick, United Kingdom. He was awarded an Engineering Doctorate in Engineering Business Management from Universiti Teknologi Malaysia (2008). He is a certified Trainer of PSMB Malaysia, certified TRIZ Instructor, certified Knowledge Management Facilitator and Practitioner, Senior Member of International Association of Computer Science and Information (IACSIT), Senior Member of South Asia Institute of Science and Engineering (SAISE) and also a senior member of International Economics of Development Research Centre (IEDRC). He is also a Chartered Engineering Research Centre and Chairman for Centre of Systematic Innovation. Dr. Yip has presented many papers in the field of engineering such as laser cladding, machining and as well as engineering management such as TRIZ, innovation management, blue ocean strategy and knowledge management in many international conferences in Japan, Korea, China, Macau, Thailand, Malaysia, Indonesia and Brunei. He is also a reviewer, Editorial Board Member, conference chair and keynote speaker for many International Journals and International Conferences.

Speech Title: TRIZ-based Systematic Innovation Problem Solving in Management

Abstract: Innovation has always been among the most crucial factors driving the progress of human civilization. Modern business environment is extremely dynamic, information technology and global networking eliminate borders, which used to keep businesses in their comfort zones, the market continuously demands better services, competition even between small company moves to a global scale. Hence, business Innovation is an important skill much needed in the knowledge based economy. With competition becoming increasingly intense, innovation is no longer a nice-to-have skill but a must-have. There is a way to learn INNOVATION in a systematic approach. The approach is called TRIZ or Theory of Inventive Problem Solving. TRIZ is a Russian methodology discovered about 66 years ago but it has remained a well-kept secret. TRIZ is a method which would support a process of generating inventive ideas and breakthrough solutions in a systematic way. One way according to TRIZ is to see a problem having contradictions. From TRIZ's much researched contradiction matrix table, suggestion for the solutions are given once contradictions are determined.

ED3002 14:00-14:20	Considerations of Unlimited Applications of Gene Editing Miyako Takagi Tokyo Online University, Japan Abstract : CRISPR-Cas9, a current mainstream method for gene editing, has been broadly used by biologists due to its speed, simplicity, and low cost. It allows medical scientists to alter DNA with greater precision than previously existing gene editing techniques. In April 2015, Chinese scientists for the first time edited the DNA of human embryos using CRISPR-Cas9. Although the team had no intention of creating so-called designer baby born from an embryo which has been genetically modified to produce desirable traits, the experiment set off shock waves across the globe. Critics have warned that interfering with human genes could have unintended, negative consequences on future generations. CRISPR-Cas9 is not a complicated technology, and biohackers have attempted to alter their own genes to promote muscle growth or nullify human immunodeficiency virus (HIV). Furthermore, a scientist posted a "do-it-yourself (DIY) Human CRISPR Guide" online and tried to sell DNA for \$159. Regarding such new DIY bioengineering movements, the regulatory framework has failed to curb these issues not only in the United States but also in many other countries. However, in January 2018, the World Anti-Doping Agency (WADA) officially added genetic engineering to its list of banned substances and methods, with the updated list including "gene editing agents designed to alter genome sequences and/or the transcriptional or epigenetic regulation of gene expression." Although the use of gene editing for doping has not been reported, the development of evaluation methods that can detect gene editing is warranted before the Tokyo Olympics and Paralympics in 2020.
ED3007-A 14:20-14:40	 Social Influences and Marketing Communications as Antecedents for Brand Preference of Mobile Phones Jeevarathnam P Govender and Tafadzwa Ndadziyira Durban University of Technology, South Africa Abstract: The mobile phone industry is facing significant growth, especially in developing economies such as South Africa. This has seen an introduction of cheaper mobile phones on a large scale, together with an increase in competition among mobile telecommunication service providers. A considerable amount of research has been conducted on brand preference in developed countries. There is a noticeable gap of knowledge pertaining the South African market. Thus, the aim of this paper is to examine the influence of social influences and marketing communications on mobile phone brand preference, specifically among higher education students. The study adopted a quantitative research approach. The population was made up of students studying at a selected university. Convenience sampling was used on a target sample of 378 students. The results were analysed using the Statistical Package for Social Sciences (SPSS) Version 24.0 software. The findings showed that some social influences did indeed affect mobile phone brand preference and that marketing communications had a very strong influence on brand preference for mobile phones.

ED3008-A 14:40-15:00	Abstract : Social networking sites are different from other communication mediums in that they allow users to communicate with each other and to locate like-minded individuals. Once they find each other, they can form communities based on their mutual interests. Thus, social networking sites help shift power from the organisation to the consumer. As social networking sites continue to grow in popularity, firms can no longer solely rely on traditional mediums to create and maintain public perception of their product. Organisations now have an opportunity to maintain a persistent connection with their consumers. These social networking sites can help to identify their most influential consumers, encourage participation in product development, and improve brand sentiment. Social networks can be used to raise awareness; connect events with attendees; inspire and educate; share insight and provide support; share tricks of the trade and create community for customers. Social networks have become a way of life for many people who use them to connect and communicate with the world at large. The purpose of the paper was to determine whether social networks have an influence on higher education students' lifestyles and behaviour. This research was descriptive and quantitative in nature. The sample comprised 386 students studying at the Durban University of Technology (DUT) in South Africa. The results indicated that the majority of the respondents preferred Facebook as their social network five times or more per day. 	Discipline power: A Cathedral of Research on the Academic Sexual Harassment in Chinese College Weiwei Wang Guangdong University of Foreign Studies, China
ED3010 15:00-15:20	Abstract: This research discusses the reasons of academic sexual harassment in Chinese college. The focus of this research is on college students as victims of academic sexual harassment. Several hypotheses were made based on the theory of discipline power and micro-power by Michel Foucault. The result indicates that discipline power has an effect on the college students in the family, society and college. What is more, micro-power functions as a network of relations from top to bottom, but also to a certain extent from bottom to top and laterally, and affects those college students. These powers penetrate into college students, making them easier to accept as standard principle in daily life, then leading students to receive academic sexual harassment unconsciously.
	Historical Inspiration of the Rise and Fall of the Silk Road Lei-Xinghe Nanjing University, China
ED3011 15:20-15:40	Abstract: Gansu is one of the main parts of the silk road through the territory, while the other part is the central Asia and west Asia of the Soviet union. In the prosperous period of the silk road, no matter it is inside or outside the country, its development in politics, economy and culture are basically the same, but in the several hundred years of the silk road decline, gansu lags far behind central Asia in economy. The rise and fall of the silk road in history has given us too much historical inspiration. The party central committee proposed the construction of the silk road economic belt, which is not only a strategic development vision but also a practical one. At the same time, it also conforms to the new trend of international exchanges and cooperation in today's international economic globalization.

ED3012-A 15:40-16:00	Revisiting Physical Education in Taiwan Primary School During Japanese Colonial Period (1895-1945) Chin, Hsiang-Pin National Kaohsiung Normal University, Taiwan Abstract: This study aims to reconstruct the developing trajectory of physical education in Taiwan primary school during Japanese colonization. Through reviewing historical documents, newspaper and governmental archives, this study finds: 1. The introduction of Taiso-ka (gymnastic) and establishment period (1895-1921): under the Japanese colonial governance, school physical education in Taiwan was implemented along with the modern school system. With the announcement of first 'school gymnastic curriculum instruction' in 1917, a formal gymnastic curriculum was established, which help to promote 'physical education' in the Taiwan society. 2. The unifying period of physical education (1922-1936): the Japanese colonizer softened its ruling measures and implemented 'educational desegregation' at school, in particular after the 'revision of Taiwan education enactment'; the primary school physical education in Taiwan finally had a well-structured law reference in terms of educational purposes, contents and methods. By 1933, the school system in Taiwan was basically unified with motherland Japan. This also gave Taiwanese the chance to compete with Japanese on the same ground, and opened up the opportunity. 3. Tairen-ka (Military physical training) period under militarism: with the outbreak of Sino-Japan war in 1937, school
	physical education was required to include Budo (martial art) class since 1937, this showed that school physical education had turned into military training. After the outburst of Pacific War, Taiso-ka (gymnastic) was renamed as Tairen-ka (military physical training). This 'physique improvement' was to be both mental and physical prepared for combat, which also revealed the transformation of physical education in primary school in Taiwan during wartime. Problems and Obstacles in Learning English as a Foreign Language Choosri Banditvilai and Robert Cullen Kasetsart University, Thailand Abstract: The purpose of this study is to identify the main problems and difficulties of non-English
ED3015 16:00-16:20	major students at Kasetsart University, Kamphaeng Saen Campus, and to make subsequent recommendations. The approach has been to provide a questionnaire to 520 students from a broad range of disciplines at Kasetsart University to gain details of their main difficulties in learning English. The findings indicate that, writing was generally thought to the biggest problem area followed by listening. Results also indicate that the great majority of students do not study or practice English on a daily basis. This study concludes with recommendations for 'Writing' courses, focusing on basic grammar structures to be introduced and for a comprehensive 'Listening' course to be added to the curriculum. The question of student motivation is considered as pivotal in this discussion and the study ends with a call for further research to be conducted in this field.
	In His Eyes: The Muslim Woman of Philippine "Canonical" Short Fiction Fatimah Joy Santos Almarez De La Salle University, Philippines
ED0001-A 16:20-16:40	Abstract: This paper explores the "carrying across" of Muslim woman in/through selected Philippine short fiction; namely, Ibrahim A. Jubaira's "Blue Blood of the Big Astana" and Mehol K. Sadain's "Old Father." The two shorts stories are chosen because of their relevance to the Muslim literary discourse, and their capacity to substantiate this study's contentions: 1) they are written by affluent, male Muslim writers who graduated from Westernized educational systems, and 2) they are "canonical," meaning they have been well-published and anthologized. Engaging with arguments made by Edward Said (on representation) and Gyatri Chakravorty Spivak (on subalternity), this study argues that the Muslim woman is excluded from the narrative of violence, her roles relegated to those tied with home and familya wife, a mother. Ironically, despite being voicelessand therefore needing to speak through a man's voicethe Muslim woman is not without influence in her world. On the contrary, she is (re)imagined as a catalyst of change. The study makes its case by juxtaposing historical (re)imaginings of the Muslim woman with literary

	ones, and by close reading selected texts through a postcolonial, feministparticularly Simone de Beauvoir's thesis of a woman's existence defining herselflens. Muslim woman, viewed through the lens of Muslim man, this paper forwards, is a subversive figure mainly because of the possibilities of her position as well as the very stereotypes she is made to embody.
ED0008 16:40-17:00	Objects and the Malay Living Room Zarina Za'bar and Syed Iskandar Ariffin Universiti Teknologi Malaysia, Malaysia Abstract: This research seeks to explore the importance of displayed objects in the living room of a Malay house. Whether the objects are for everyday consumption or merely decoration, the following discussion suggests an approach that firmly implies how things are used, lived, and appropriated into the Malay's everyday life. The classification of displayed objects and in-depth interviews were conducted within 30 selected Malay houses throughout Malaysia in this research. The article develops and complements existing ideas and knowledge in Malay cultural living from the past and the present that focuses on the appreciation and understanding of the complex relationships between Malay people and their things: the making, history, preservation, and interpretation of objects. The present study contributes to the existing research by extensively identifying displayed objects in the selected living room, and the relationship relates to how objects act as the embodiment of meaningful connections between ancestors, kinfolk, friends, and other people within their homes. The study is explored via five observed methods of presentation within the living room: objects as an inheritance; objects as a remembrance; objects as affluence; affable objects; and symbols of faith.
ED1004 17:00-17:20	The Destruction of Cultural Heritage and the Suggestions on Preventing This Destruction: Turkey Model Özdemir Ko gak and Nuriye Külahlı University of Sel quk, Turkey Abstract: We have been doing archaeological surveys in the west of Turkey for 17 years. Also, in this region we carried out excavations in "Dede Mezarı Cemetery", Middle Bronze Age Cemetery for five years. During these studies, it has been found out that the thousands of years old sites were destroyed by illegal digs and agricultural activities. It is clear that in nearly all the 298 sites we have located in this region so far, there are such damages. Because of this situation, some of the mounds have disappeared totally. During the excavations we did in the MBA "Dede Mezarı Cemetery", it was seen that ¾ of this cemetery was destroyed by the same reason. The most important way to prevent these relics to raise the awareness of the security units and local community. It should be explained that the sites and the works that have come out of here have universal character; they should be protected and the archaeologists, art historians or historians who are expert on their fields can do excavations here. It should be emphasized that when the studies are carried out on a scientific level, the results will make a contribution to the development of the region, as well. Because people should be gathered from the local community in order to carry out these studies and certain amount of money will be paid for them. Moreover, the historical area will be brought in tourism and the works extracted from here will be exhibited in museums. So a long-termed and permanent source bearing no risk has been produced. These informative studies which are for local administrators and local people should be as regular workshops, conferences or field practice. It is crucial that the protection awareness of the archaeological sites should be gained at early ages. For this reason, the students in the educational institutions should be taken to these sites regularly and the imp
